## WHAT MAKES A GOOD NOMINATING PACKAGE?

These guidelines are for your use in selecting and justifying the Award category and in commenting on the achievements of your nominee. While we appreciate that you may not have a resume of the nominee available, it would help the Committee if you could supply as much background information as possible. It is also recommended that this research and collection of materials be done discreetly. An excellent nomination package includes the basic information contained in a CV, plus a robust biography which details all key career milestones. Additionally, an ideal package includes several (3-5) letters of recommendation from community and business leaders and influencers, media clips or news releases, and any other information which would aid in telling the “story” of the candidate. ## CRITERIA FOR SELECTING CANDIDATES

In order to be considered for the Nova Scotia Business Hall of Fame, it must be demonstrated that candidates have fulfilled criteria 1 [either (a) or (b)] and one more of the other two criteria, as listed below.

To be recognized by his or her business or profession as having made an outstanding contribution to the success of the business or profession;

or

To have demonstrated in his or her business career entrepreneurial spirit and to have a record of outstanding entrepreneurial achievements

2

To have demonstrated effective leadership, not only within his or her own organization but in the community;

3

To be considered a role model for future generations of entrepreneurs and business leaders, as well as others in business.
